1.	Passed initial practical assessment?	Candidate can proceed and attempt the written examinations.
2.	Failed initial attempt at practical assessment?	Candidate can attempt 1st practical re-sit.
		Candidate can also proceed for written examination before completing the 1 st practical re-sit. In this instance one of the written components must be passed to allow the candidate to attempt the 1 st practical re-sit.
3.	Passed 1st practical re-sit attempt?	Candidate can proceed and attempt the written examinations. If one or more written components is passed the 1 st re-sit practical score will stand.
4.	Passed 1st practical re-sit attempt and passed 1 written component?	1st re-sit practical score will stand.
